1. 25-1468 APPOINTMENT - CITY COUNCIL PRESIDENT

Recommendation: That City Council appoint one of its members as President for a period of one year, expiring November 24, 2026.

Council Vice President Patton, who was nominated by Council Members Wiggins and Broughton and was the only nominee, made brief comments.

Council Member Wiggins made a motion to approve and Council Member Brahier seconded that City Council appoint as its President, Council Member Allison Patton, by acclamation for a period of one (1) year expiring November 24, 2026.

2. 25-1469 APPOINTMENT - CITY COUNCIL VICE PRESIDENT

Recommendation: That City Council appoint one of its members as Vice Present for a period of one year ending November 24, 2026.

Council Member Wiggins who was nominated by Council Member Broughton, first made comments commending outgoing Council President Moore and congratulating Council President Patton. He then indicated that he would be withdrawing his name from consideration and allowing Council Member Brahier the opportunity to fill the role of Vice President.

Council Member Brahier made follow-up remarks.

Council Member Bare made a motion to approve and Council Member Wiggins seconded that City Council appoint as its Vice President, Council Member Jennifer Brahier, by acclamation for a period of one (1) year expiring November 24, 2026.

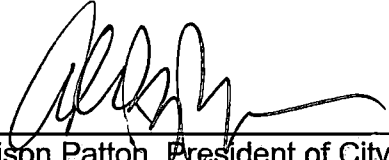
Council Member Brahier made follow-up remarks.
